Proflex is a formulation utilizing Capitanage<sup>III</sup> Dechnology which is a proprietary blend of ingredients for use with the active ingredient Lambda-cyhalothrin. Proflex is for use as a general surface (nonford/ornoled areas), crack and crevice, or goot treatment in, on, and around buildings and structures and their immediate surroundings, and on modes of transport. Areas of use include, industrial buildings, houses, pratios, porches, closets, furniture, apartment buildings, mobile homes, laboratories, buses, greenhouses (non-commercial), stores, factorities, warehouses, vineiries, vessels, railcars, trucks, trailers, aircraft (cargo and other non-cabin areas only), schools, nursing homes, hospitals, mausoleums, restaurants, hotels, correctional facilities, livestock/poultry housing, pet kennels, food granaries, food grain mills and food manufacturing, processing, and servicing establishments.

## DIRECTIONS FOR USE

#### Mixing Instructions

Dilute Proflex with water for application using hand-held or power-operated application equipment as a coarse spray for crack and crevice or spot and general surface (nonfood/ norfleed areas only) treatments. Application equipment that delivers two volume treatments, such as the Micro-Injector®or Actisol® applicator, may also be used to make crack and crevice or spot and general surface treatments. Fill applicator tank with the desired volume of water and add Proflex. Close and shake before use in order to ensure proper mixing. Shake or re-apilate applicator tank hefore use if application is interrupted. Mix only amount of treatment volume as required. Proflex may be applied by using a paintbrush or other porous applicator attached to a handle as a general surface treatment. If mixture is allowed to sit for more than 2 hours, shake well before application.

## Tank Mixing

Proflex may be tank mixed with other currently registered pesticides unless expressly prohibited by the product label. A small volume mixing test with the other products is recommended to ensure compatibility. If other chemicals are added to the applicator tank, add **Proflex** tast. If mixed with EC formulations, use within 24 hours. Fill tank to desired volume and continue to aditate while making applications.

#### **Foam Applications**

Proflex may be converted to a foam and the foam used to treat structural voids to control or prevent pests including ants, bees, termites (above ground only), wasps, or other listed arthropods harboring in walls, under slabs, or in other void areas.

## FOOD HANDLING ESTABLISHMENTS

## (Places other than private residences in which food is held, processed, prepared, or served):

Application within Food Serving Areas: For facilities where foods are served, such as dining rooms. Apply as a crack, and crevice or spot treatment to selective surfaces such as baseboards, under elements of construction, and into cracks and crevices. Do not treat surfaces likely to be contacted by food. (Do not apply when facility is in operation or foods are exposed.) Food must be covered or removed in area being treated. If used as a spot or crack and crevice treatment, Proflex may be applied in both food/feed and nonfood areas of food/feed handling establishments.

Use as a crack and crevice or spot treatment in and around both food and nonfood areas. Apply in small amounts directly into cracks and crevices, using equipment capable of delivering a pin stream of insecticide, in points between different elements of construction, between equipment and floor, openings leading to voids and hollow spaces in walls, equipment and bases. Clean food contact surfaces and equipment with an effective cleaning compound and rinse with potable water before using.

These properties will gradually result in the reduction and eventual elimination of the flea population. Flea eggs and flea larvae that come into a contact with Proflex will also not develop into adult fleas. Proflex works for up to 7 months by inhibiting the development of the immuture stages of the flea and prevention them from reaching the tase.

Application of Proflex prior to the flea season will aid in reducing developing populations. Apply to areas where pets and other animals are known to frequent and where previous infestations have been known to occur to prevent the emergence of adult fleas and also control stages of fleas that don't resemble adult fleas.
